
What is an Actuary?

Working From Home


- Set up working space bedroom / kitchen / spare room home





Domestic Market




The total domestic premium income was €11.65bn in 2019. €9.7bn was paid out in benefits and claims in 2019

Life insurance companies employed 7,987 people in Ireland in 2019. Total value of in force life assurance protection policies in 2019 was €490.8bn Total value of policyholder's funds managed was €131.2bn in 2019. Majority of investments are held in equities (60%)



Domestic Market


Total Domestic Market Premium - Split By Product Type (€bn)





Total Domestic Market Premium - Breakdown By Company



The Role of a Life Actuary




Actuaries can fill several diverse roles within the operations of a life insurance company.


These include, but are not limited to:

- Reserving
- Pricing
- Regulatory and financial reporting
- Product design
- Capital management (including Economic Capital)
- Solvency projections (Own Risk & Solvency Assessment)
- Risk Function (CRO)

What is a consultant?

- Someone who gives expert advice to a person or organisation on a particular subject
- A professional they know their area of expertise and can be relied on to give appropriate advice
- Typically advise an external client and have a close relationship with client while carrying out specific tasks/work
- Remunerated in line with the work/project carried out

Areas of work (1)

- Many consultancies operate in insurance covering areas such as:
 - Life insurance
 - Non-life insurance
 - Reinsurance
 - Healthcare
- Other operators are in the pensions field

Areas of work (2)

- Further areas in which consultancies operate include:
 - Investment
 - Personal Financial Advice
 - Enterprise Risk Management
 - Family Law
 - Litigation
- A number of consultancies cover multiple disciplines and can operate across several geographical areas

Areas of work (3)

- Other consultancies would be smaller operations perhaps in a single field or geographical area or a limited number of areas



Why become a consultant? (2)


- Exposure to a range of clients from various disciplines

Scope to bring in business/economics/accounting knowledge in a business setting to be more than just a number cruncher


- Artificial Intelligence



- Capital Modelling
 - Solvency Capital Requirement
 - Internal model or Standard Formula
 - IFRS17 Readiness





- Pricing
 - Identifying factors which predict level of risk of customers
 - Analysis of business performance
 - Big data and predictive analytics
- Risk
 - Identifying, measuring and monitoring risk
 - Own Risk and Solvency Assessment (ORSA)



- KRIs





• Differential Pricing:



- Differential pricing is where customers with a similar risk and cost of service are charged different premiums for reasons other than risk and cost of service.
- Current pricing practices can lead to unfair outcomes for car and home insurance consumers.
 - Price walking ban
 - Providers review their pricing policies and processes annually
 - Consumer consent and disclosure requirements




- Data Analytics
 - Machine Learning
 - Telematics/Usage-Based Insurance
 - Fair price regulation





- IFRS 17
 - New accounting standard for insurance contracts
 - Comes into force in 2023
 - Discounting of Reserves
 - Structure : BEL + RA + CSM
